AIA Competition Guidelines

These guidelines are set so that all participating teams will be subject to the same requirements. After reading the guidelines, both of your contact representatives should sign the Cappella & Dance Competition Application (Page 2 of the Packet) and then return it to AIA. Your application will not be processed until the form is signed and the registration fee received.

➤ General Competition Guidelines:

1. Each team must comply with the deadlines listed on the timeline.
2. Failure to do so will affect your final score.

➤ Requirements for All Competing Teams:

1. Each team must have at least 5 to 18 members.
2. The entire performance cannot exceed 10 minutes.
3. A group may use its 10 minutes any way it likes Groups that go over the time limit risk disqualification.
4. Failure to comply with any of these requirements may result in disqualification

➤ AIA Competition Guidelines (Continued)

Playhouse Rules

1. Smoking is prohibited in all areas of the building.
2. Food and beverages are prohibited in seating areas.
3. Animals are prohibited in all areas

4. Fire and safety regulations shall be in accordance with the University, City, and State codes and shall be enforced by the Production Manager of Zellerbach Hall.
5. Open flame, fireworks, flashpots or other pyrotechnic devices are strictly prohibited.
6. Two wire electrical devices, except where internally grounded and insulated, are prohibited.
7. No scenery drops, properties, decorations, or other combustible effects shall be placed on any stage or any platform, unless they are made from a nonflammable material or treated with an effective fire-retardant solution and maintained in a nonflammable condition in accordance with Section of the Health and Safety Code of ILLINIOS. Users may be required to provide Cal Performances with a certificate stating the nonflammable treatment of each item mentioned above.
8. Users shall not erect or operate within the building any engine or machinery powered electrically, manually, or by air or steam, except on stage in approved commercial theatrical devices; no oil-burning fluids, kerosene, solvents, gasoline, or other highly volatile fluids shall be used for any purpose.
9. Materials or equipment containing asbestos are prohibited.
10. Movement of Furniture must be approved and supervised by the custodian.
11. Event must conclude and all parties vacated by 10:00 pm.
12. Containers of Liquid shall not be placed on furniture other than tables.
13. Candles must be in a glass container, hurricane, or votive holder.

Additional Information:

1. Each competing team must have at least 100% of its members present on July 23th, 3:00 pm before the competition.
2. Performance order will be randomly determined during the team mixer dependent on adherence to rule 1 above.
3. The deadline dates reflect the dates received by, not the postmark date.
4. Food will be provided

*There are no exceptions to the deadlines unless explicitly notified by AIA.

Dance Judging Information And Criteria

About The Judges:

There will be a total of 3-4 judges, to be selected by AIA Council.

The Judging Procedure:

1. Each judge will rate each performance and award 0 – 10 points to each team.
2. The highest and the lowest scores will be discounted and the scores of the remaining judges will be equally weighted.

3. Each judge will sign and seal his/her scoring sheet and give it directly to an independent accountant, who will calculate the final scores at the end of the competition.
4. Total score will be based on 80% of the judges + 20 % audience
